

PLAN OF CONVERSION

This Plan of Conversion ("Plan") is entered into this 28th day of December, 2020, by Mihail Stoyanov ("Stoyanov"), the sole member and manager of Laketown 631 LLC, a Colorado limited liability company ("Laketown").

- 1. <u>Conversion</u>. Pursuant to the terms and subject to the conditions stated herein, Laketown will be converted from a Colorado limited liability company to a Florida limited liability company with the name "Laketown 631 LLC", which limited liability company will continue in existence as the resulting entity under the laws of the State of Florida.
