

PLAN OF CONVERSION

This Plan of Conversion ("Plan") is entered into this 28th day of December, 2020, by Mihail Stoyanov ("Stoyanov"), the sole member and manager of Laketown Wharf 734 LLC, a Colorado limited liability company ("Laketown").

- 1. <u>Conversion</u>.
