**ARTICLES OF ORGANIZATION  
OF  
SHIH ORTHODONTICS, PLLC**

Pursuant to § 605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I  
NAME**

The name of the limited liability company is Shih Orthodontics, PLLC (the "Company").

**ARTICLE II  
EFFECTIVE DATE AND DURATION**

The effective date upon which the Company shall come into existence shall be the date these Articles of Organization are filed with the Secretary of State. Unless earlier terminated pursuant to the Act or the Operating Agreement (as defined in § 605.0105 of the Act) of the Company, the period of its duration shall be perpetual.

**ARTICLE III  
PURPOSE**

The general purpose for which this professional limited liability company is organized shall be (i) to render dental services to the general public, and to do all things in connection therewith that are customarily done by dental professionals under the laws of the State of Florida and (ii) in furtherance of its corporate purposes, the professional limited liability company shall have all of the general and specific powers and rights granted to and conferred on a company by the Professional Services Limited Liability Company Act.


