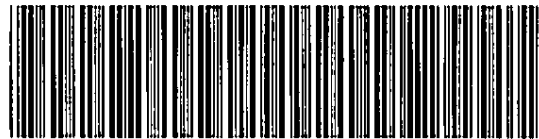



**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
SHARPENTERS 1965, LLC**

Pursuant to the provisions of Florida Statutes Section 605.0202, Sharpenters USA, LLC, a limited liability company organized and existing under the laws of the State of Florida, hereby adopts the following Amended and Restated Articles of Organization:

1. The present name of the Company is Sharpenters USA, LLC.
2. Sharpenters USA, LLC filed its Articles of Organization with the Department of State of the State of Florida on January 4, 2021, and was assigned Florida document number L21000013591.
3. The Articles of Organization of Sharpenters USA, LLC are hereby amended and restated to read as follows:

ARTICLE I

Name

The name of the Company is Sharpenters 1965, LLC and its street and mailing address is 4527 Arnold Avenue, Naples, Florida 34104.

ARTICLE II

Duration

The Company shall commence its existence on the date of filing of Articles of Organization with the Department of State of the State of Florida and the duration of the Company is perpetual.

ARTICLE III

Purposes

The general purposes for which the Company is organized are:

1. To transact any lawful business for which limited liability companies may be organized under the Florida Revised Limited Liability Company Act.

2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

Registered Office and Agent

The street address of the registered office of the Company is 4527 Arnold Avenue, Naples, Florida 34104, and the name of its registered agent at such address is Daniel Langsten.

ARTICLE V

Termination of Existence

The Company shall not be dissolved upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company.
