



# AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF SHARPENTERS 1965, LLC



Pursuant to the provisions of Florida Statutes Section 605.0202, Sharpenters USA, LLC, a limited liability company organized and existing under the laws of the State of Florida, hereby adopts the following Amended and Restated Articles of Organization:

- 1. The present name of the Company is Sharpenters USA, LLC.
- 2. Sharpenters USA, LLC filed its Articles of Organization with the Department of State of the State of Florida on January 4, 2021, and was assigned. Florida document number L21000013591.
- 3. The Articles of Organization of Sharpenters USA, LLC are hereby amended and restated to read as follows:

# ARTICLE I

# Name

The name of the Company is Sharpenters 1965, LLC and its street and mailing address is 4527 Arnold Avenue, Naples, Florida 34104.

# ARTICLE II

# Duration

The Company shall commence its existence on the date of filing of Articles of Organization with the Department of State of the State of Florida and the duration of the Company is perpetual.

# ARTICLE III

# **Purposes**
