**ARTICLES OF ORGANIZATION
OF
TRILOGY TUNNEL FLIGHT, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is TRILOGY TUNNEL FLIGHT, LLC.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 120 East Main Street, Suite A, Pensacola, FL 32502, and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Manager.

**ARTICLE III
MANAGEMENT,**

The business of the Company shall be managed by a Manager(s) selected by the Members. The initial Managers shall be James J. Marks, III and James J. Marks, Jr., each of whom shall serve as a Manager of the Company until his resignation or death, or as otherwise provided in the Operating Agreement of the Company.

**ARTICLE IV
RESTRICTIONS ON MEMBERSHIP**

New members may only be admitted as provided in the Operating Agreement of the Company. A member's interest in the Company may only be sold or transferred as provided in the Operating Agreement of the Company.

**ARTICLE V
AMENDMENT TO ARTICLES**

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Chapter 605 of the Florida Statutes, and approved by the Manager of the Company.
