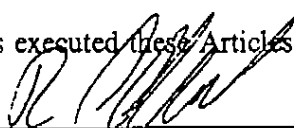
ARTICLE VIII

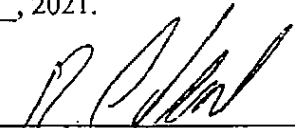
