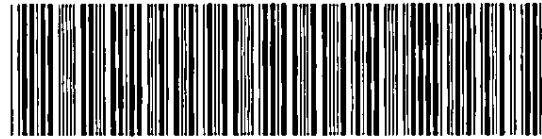

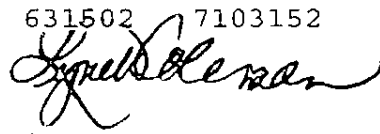

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

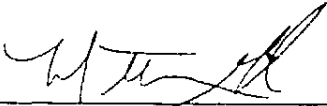
4. Place of Business. The mailing and street address of the Company's principal office is 1037 5th Ave North, Naples, Florida 34102.

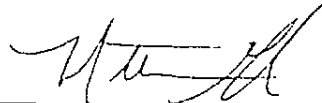
