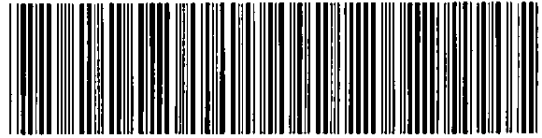

FIRST: The name of the Limited Liability Company is **4304 ONE PARAISO LLC**.


