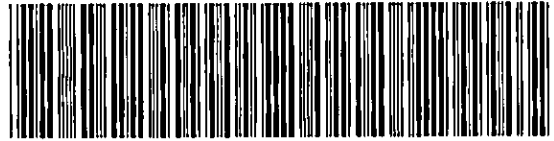

The name of the Company shall be MCC Insurance, LLC.


### ARTICLE II. ADDRESS


