# ARTICLES OF ORGANIZATION OF JKM ACQUISITIONS, LLC

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Organization for the purpose of creating a limited liability company under the laws of the State of Florida.

#### **ARTICLE I**

The name of this limited liability company shall be: JKM Acquisitions, LLC

#### **ARTICLE II**
