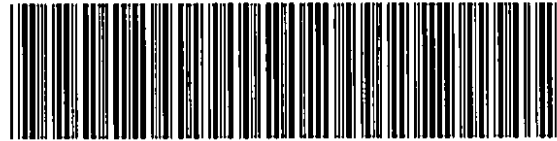


ARTICLE IV – MANAGEMENT
