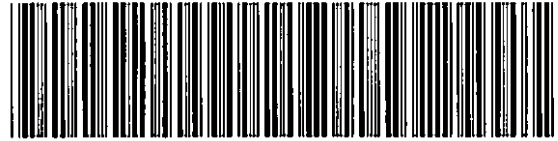




ARTICLE IV – MANAGEMENT
