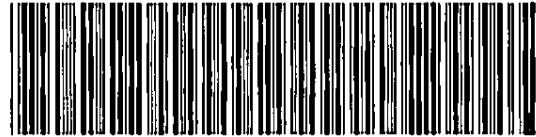

REGISTERED AGENT AND REGISTERED OFFICE


The name of the Registered Agent is DELOACH, P.L. The Registered Office is located at 1206 East Ridgewood Street, Orlando, Florida 32803.
