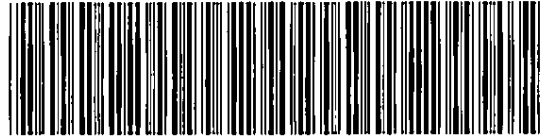

Principal Office




