ARTICLE IV – MANAGEMENT

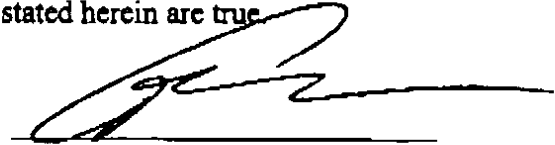
The Company shall be managed by one or more managers.
