DURATION**

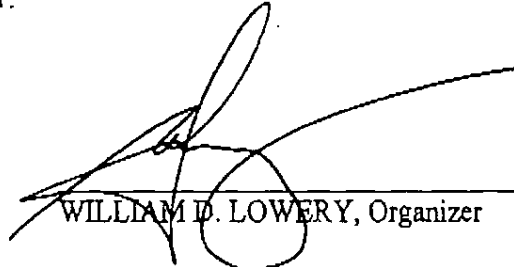
The Company's existence shall commence on January 29, 2021, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

The Company shall be managed by one or more managers as provided in the Company's Operating Agreement and the initial manager(s) of the Company shall be WILLIAM D. LOWERY.

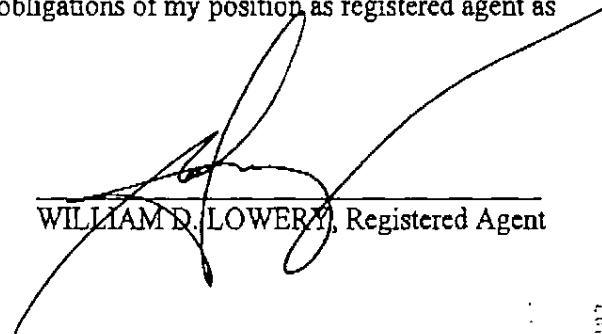
