We are attaching the documents we think it may be necessary.



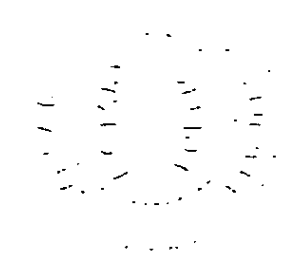


