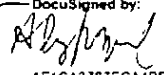
## Assignment of LLC Interest

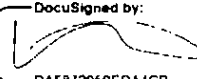
Whereas, Assignors are the 100% owner of Tampa Roofing and Construction LLC, a limited liability company.

3. The Assignment is effective as of June 29, 2021.

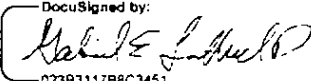

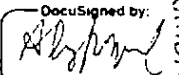

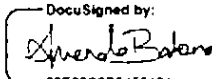
