ARTICLES OF ORGANIZATION

ARTICLE I
NAME

The name of this Limited Liability Company is DYNAFIRE PARK IV, LLC.

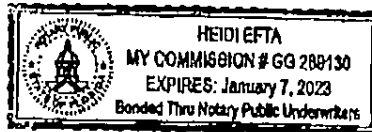


