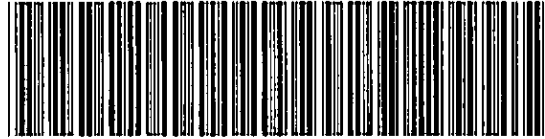



REPORT AND RECOMMENDATION OF GENERAL MAGISTRATE
FINAL HEARING/SIMPLIFIED DISSOLUTION OF MARRIAGE

THIS CAUSE came before the undersigned on _____, for Final Hearing on the Petition for Simplified Dissolution of Marriage, the Petitioner and the Respondent having appeared *pro se*.

After hearing testimony and being fully advised in the premises, the undersigned makes the following findings of fact and conclusions of law.

This Court has jurisdiction over the subject matter of this proceeding, at least one of the parties having resided within the State of Florida for at least six (6) consecutive months immediately prior to the filing of the Petition.

The Court has jurisdiction over the parties. Respondent filed an Answer and Waiver.

This matter is properly before the undersigned pursuant to an Order of Referral.

The parties were married to each other on December 28, 2013 at Pasco County.

The marriage is irretrievably broken and should be dissolved.

There have been no children born or adopted of the marriage and none are expected.

The Wife seeks restoration of her former name. Her former name should be restored and she should be known hereafter as ANNA MARIA GUNNARSSON.


Both parties have waived the ten (10) day objection period of Fla. Fam. L.R.P. 12.490.

FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

It is therefore:

- a: The marriage between the parties is hereby dissolved and the parties are restored to the status of being single.
- b: The parties have no minor children together and none are expected. There are no marital assets or debts subject to equitable distribution.
- c: The findings, conclusions and relief recommended by the General Magistrate are approved, ratified, confirmed and incorporated into this Final Judgment as if each and every recommendation were specifically set forth herein.
- d: This Final Judgment shall have the effect of a duly executed instrument of conveyance, transfer, release and acquisition of any real property described in the Marital Settlement Agreement and/or Report and Recommendations of the General Magistrate, when recorded in the official records of the county in which the property is located.
- e: The Wife shall have her former name restored unto here, to wit: ANNA MARIA GUNNARSSON, by which she shall henceforth be known.
- f: The court reserves jurisdiction to enforce the Marital Settlement Agreement.
