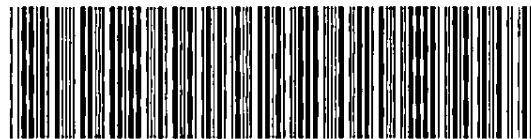


ARTICLE V – MANAGEMENT


