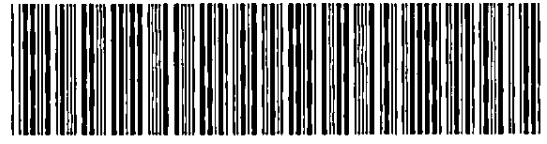

ARTICLE VI - NEW MEMBERS






