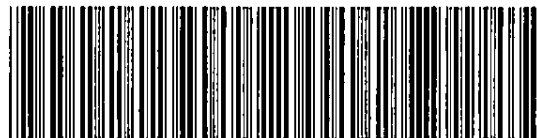


- FIRST: These Articles of Amendment amends the Articles of Organization of PSP Partners, LLC (the "Company").
