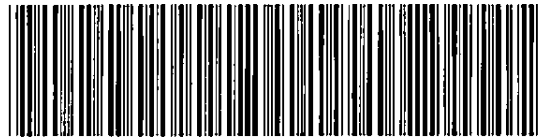

Hereby, I, Reyna Rosales Araisa, am writing to you to inform you that on Saturday, March 23, my Limited Liability Company named INVESTMENTS KLD LLC document number

L21000063167 suffered a modification that I did not authorize by Mr. Lot Edinson Suarez, who does not have permission to make decisions that lead to an amendment within the Sunbiz system in relation to my company.

Since I, Reyna Rosales Araisa, in my capacity as principal member, own 85% of the decisions in accordance with the Operating Agreements drawn up on November 12, 2023. In accordance with said Operating Agreements, Mr. Lot Edinson Suarez does not have the authority to make changes without my express consent.

Referring to the bottom of your last email which reached the email address of my registered agent Katherim Romero katherimromero@gmail.com which was also removed without my consent, I quote the following: The false information presented in a document to the Department of State constitutes a serious crime of the third degree as provided in art. 817,155, FS.

Furthermore, I wish to emphasize that Mr. Lot Edison Suarez made the voluntary decision to exit this Limited Liability Company on December 7, 2023.

I attach the relevant documentation as proof of the above. Therefore, I respectfully request that steps be taken to ensure that Mr. Lot Edinson Suarez is not able to make any changes on behalf of INVESTMENTS KLD LLC, and that any modification requests be rejected without my prior consent.

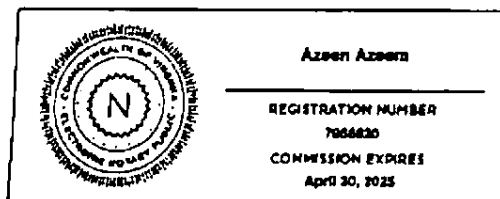
