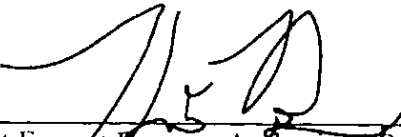
ARTICLE V – MANAGEMENT

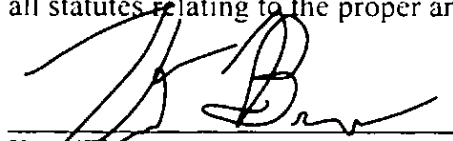
