The name of the limited liability company shall be Heart & Vascular Ambulatory Surgery Center, LLC (the "Company")."

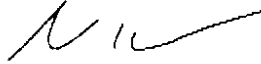
THIRD: Article II of the Articles of Organization shall be deleted in its entirety and the following text was adopted by the limited liability company as the new Article II to its Articles of Organization:
