1. Name. The name of this limited liability company is **WESTON SMITH LAW, PLLC** (the "Company"), and it shall be formed as a professional limited liability company under Chapters 605 and 621 of the laws of the State of Florida.

4. Management of the Company. The management of the Company shall be vested in the manager of the Company. The name and address of the initial manager of the Company as follows:


