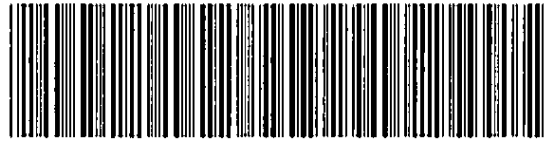

The mailing address and street address of the principal office of the Company shall be 17724 Hunting Bow Circle, Suite 101, Lutz, FL 33558.


ARTICLE III. REGISTERED AGENT AND OFFICE


