**ARTICLES OF ORGANIZATION

**ARTICLE VI**

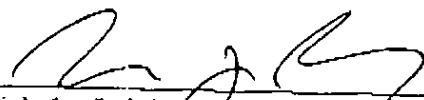
**Membership Units**
