The Company shall be managed by a **manager** or **managers** in accordance with the Articles of Organization, the Operating Agreement, the Regulations adopted by the members for the management of the business and the ordinary and customary affairs of the Company. The Regulations and the Operating Agreement, if any, shall determine the manner in which such the Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these Articles of Organization. ARTICLE XI. LIMITATION ON AGENCY AUTHORITY OF MEMBER

ARTICLE XII. INDEMNIFICATION

This company shall indemnify a member, manager or organizer, or any former member, manager or organizer made a party to a proceeding because that person/entity is or was a member, manager or organizer of the company against any liability incurred in the proceeding if that person/entity:

This company shall pay for or reimburse the reasonable expenses of the individual pursuant to the Revised Florida Limited Liability Company Act.
