

ARTICLES OF ORGANIZATION OF ENERGY PEACE, LLC a Florida limited liability company

The undersigned, NORBORNE A. BROWN, III, an individual competent to contract and an authorized representative of ENERGY PEACE, LLC, hereby presents these Articles of Organization as the Articles of Organization of ENERGY PEACE, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

<u>ARTICLE I - NAME</u>
