The Company is formed for an indefinite duration.

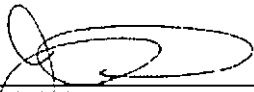

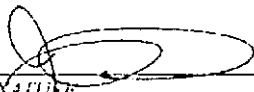
