ARTICLES OF ORGANIZATION OF VENETIAN FIVE STAR INVESTMENTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I NAME

The name of the limited liability company shall be VENETIAN FIVE STAR INVESTMENTS, LLC (the "Company").

ARTICLE III MAILING ADDRESS The mailing address for the Company shall be 145 Almeria Avenue, Coral Gables, Florida 33134 ARTICLE IV INITIAL REGISTERED OFFICE AND REGISTERED The address of the initial registered office of the floring address of the initial registered agent is 1 T 33134 and the initial registered agent is J. ARTICLE V PURPOSES AND POWERS

ARTICLE VII STREET ADDRESS OF PRINCIPAL OFFICE

The street address of the principal office of the Company shall be located at 145 Almeria Avenue, Coral Gables, Florida 33134, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

ARTICLE VIII MEMBERSHIP RESTRICTIONS

Additional Membets may be admitted to the Company. Contributions required of new Members shall be determined as of their time of admission to the Company only upon the unanimous consent of all existing Members of the Company, in accordance with the Operating Agreement of the Company. A Member's interest in the Company shall be considered personal property, notwithstanding the actual nature of the assets owned by the Company, and may not be sold or otherwise transferred except in strict accordance with the Operating Agreement of the Company.

ARTICLE IX MANAGEMENT AND AUTHORIZED AGENT

All Company powers shall be exercised by or under the authority of, and the business and affairs of this Company shall be managed by one or more Managers. Accordingly, the Company is a Manager-managed limited liability company. The Managers will also be permitted to designate one or more authorized agents to serve at the direction of the Managers.
