**ARTICLES OF ORGANIZATION

**ARTICLE I
NAME & ADDRESS**

MANAGEMENT OF THE COMPANY


The Company shall be a member-managed Company and shall be managed by its sole member, AVG INTERMEDIATE HOLDINGS LLC.




