- Two: Notwithstanding any other provisions of these Articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income


tax under Section 501 (c) (3) of the Internal Revenue Code.

Three: The property of this organization is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer, or member thereof or the benefit of any private person.

Four: On the dissolution or winding up of the organization, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this organization, shall be distributed to a non-profit fund, foundation, or organization operated exclusively for Educational and Charitable purposes under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to Church or the federal government, or to a State or Local Government for a disposed of by the Superior Court in which the principal office of the organization is located, exclusive for such purposes or to such organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
