A. Article V of the Articles of Organization of the Company is hereby added to read as follows:

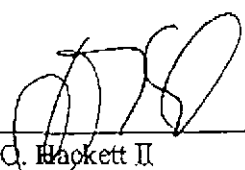
ARTICLE V – Management
