ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is JJ 11548, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be perpetual.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 10436 Portofino Circle, Trinity, Florida 34655.




