**ARTICLE I**

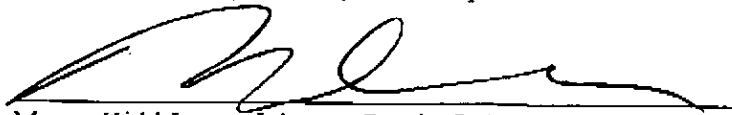
**ARTICLE III**

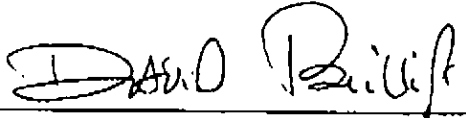
Management. The Company shall be managed and controlled by an Authorized Member or Authorized Members in accordance with an operating agreement adopted by the members for
