The Company shall be organized and shall be operated exclusively as a non-profit, tax-

exempt organization for charitable, educational and scientific purposes within the meaning of

Section 501(c)(3) of the U.S. Internal Revenue Code of 1986, as amended, and shall be operated

operations, after the payment in full of all debts and obligations of the Company of whatever

kind and nature, may be used and distributed to organizations that qualify under Section

501(c)(3) of the Code;

distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the
