- SECOND:** The Articles of Organization were filed on March 5, 2021 and assigned document number L21000097006.
- THIRD:** The date of the adoption of these Articles of Dissolution is 13 March 2022.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
