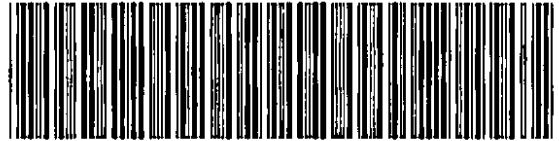

(A Florida Limited Liability Company)




The Articles of Organization of the Company are hereby amended as follows:
