Pursuant to *Chapter 605 and 621, Florida Statutes*, the undersigned desires to amend the Articles of Organization for Lambiris Plastic Surgery, PLLC, a Florida professional limited liability company, that were filed with the Florida Secretary of State under Document Number L21000097861 (collectively the "Articles of Organization") on March 8, 2021.

1. **Article II** is hereby deleted in its entirety and a new **Article II** shall replace any existing provision of the Articles of Organization. **Article II** shall read as follows:
