ARTICLES OF ORGANIZATION

OF

MODIFICATION OF ARTICLES & RESPONSABILITY

The private property of the member shall not by subject to the payment of the organization debts in any amount.

ARTICLE VII NEW MEMBERS

No additional member(s) shall be admitted to the Company except with the unanimous written consent of all the member(s) of the Company and upon such terms and conditions as shall be determinate by all the member(s).
