
ARTICLE VII



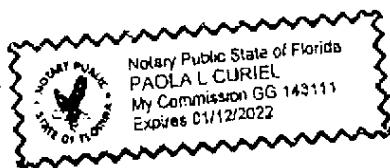
