PURPOSE-GENERAL NATURE OF BUSINESS

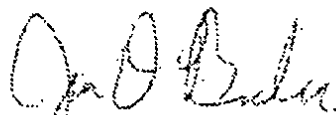
The general nature of the business to be transacted by this professional limited liability company is as follows:
