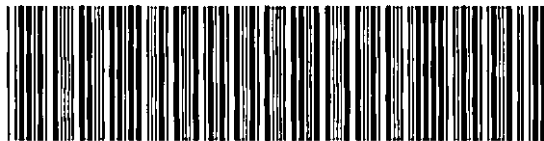

The name of the Company shall be: **LINARES REAL ESTATE 1, LLC.**

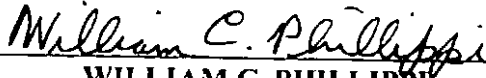
ARTICLE II
