ARTICLE I - NAME

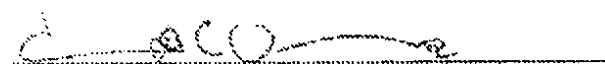
The name of this limited liability company is Rabco Solutions LLC (the "Company").

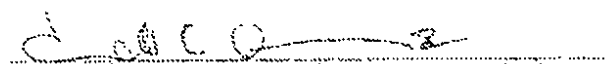
