AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF

HHMA LLC

(A Florida Limited Liability Company)

HHMA LLC hereby amends and restates its Articles of Organization filed March 3, 2021 (Document Number L21000103700) under the Revised Florida Limited Liability Company Act, Florida Statutes Chapter 605, as follows:

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, pursuant to the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Organization:

ARTICLE 1

NAME

The name of the Limited Liability Company is HHMA LLC (the "Company").

These Amended and Restated Articles of Organization shall be effective as of October 10, 2023.

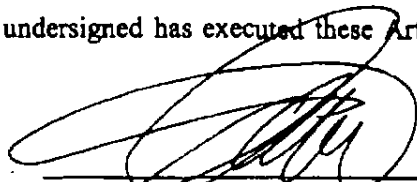
