- Article IV of the Articles of Organization is deleted in its entirety and replaced with the following:

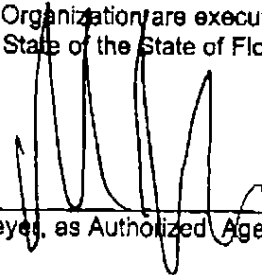
The Company shall be Manager managed and the initial Manager shall be:
